1 Thomas A. Seaman (the "Receiver"), the court-appointed Permanent Receiver
2 for Medical Capital Holdings, Inc., Medical Capital Corporation, Medical Provider
3 Funding Corporation VI and their subsidiaries and affiliates, (collectively the
4 "Receivership Entities") submits this twentieth interim application for approval and
5 payment of fees. This application covers the period August 1, 2014, through
6 October 31, 2014 (the "Twentieth Application Period").

7 During the Twentieth Application Period, the Receiver and his staff spent
8 785.1 hours executing the duties set forth in the Temporary Restraining Order and
9 Order Appointing Receiver and the subsequent Preliminary Injunction and Order
10 Appointing Permanent Receiver, and subsequent orders of the Court. During this
11 period the Receiver recovered \$57,194.68 in gross receipts for the receivership
12 estate. By this Twentieth Interim Fee Application, Thomas Seaman seeks approval
13 of \$108,902.50 in fees which were incurred at a weighted average hourly rate of
14 \$139 per hour. The Receiver seeks approval to pay 90% of this amount, or
15 \$98,012.25. The Receiver does not seek reimbursement of any expenses.

16 **I. PROCEDURAL OVERVIEW OF THE RECEIVERSHIP CASE.**

17 On July 16, 2009, the SEC commenced an enforcement action against
18 Medical Capital Holdings, Inc., Medical Capital Corporation, Medical Provider
19 Funding Corporation VI, Sidney M. Field and Joseph J. Lampariello ("Defendants"),
20 alleging various violations of securities laws. On the same day, the SEC filed an Ex
21 Parte Application for Temporary Restraining Order ("TRO") and Orders: (1)
22 Freezing Assets; (2) Appointing a Temporary Receiver; (3) Prohibiting the
23 Destruction of Documents; (4) Granting Expedited Discovery, and (5) Requiring
24 Accountings; and Order to Show Cause Re: Preliminary Injunction and
25 Appointment of a Permanent Receiver. On July 20, 2009, the Court granted the
26 TRO, however, the TRO was vacated the following day at the request of the
27 Defendants, and further briefing was submitted.

28

1 Thereafter, on August 3, 2009 (the "Appointment Date"), the Court entered
2 the TRO, appointing Thomas A. Seaman as temporary receiver for the Receivership
3 Entities. On August 17, 2009, the Court confirmed the appointment of the Receiver
4 and entered the Preliminary Injunction and Order Appointing a Permanent Receiver
5 ("Appointment Order"), by which Mr. Seaman was appointed as the Permanent
6 Receiver for the Receivership Entities.

7 **II. SCOPE OF THE RECEIVERSHIP CASE.**

8 The Receiver has set forth the scope of the case in detail in his nineteen
9 previous fee applications, and will omit it from this application in the interest of
10 brevity given the late stage of the receivership and out of respect for the significant
11 time and judicial resources this Court has devoted to this case.

12 The Receiver's Forensic Accounting Report clearly indicated that the
13 Receivership Entities' lending and investing activities were not profitable,
14 notwithstanding that the Receivership Entities were showing a reporting profit on
15 their financial statements and income tax returns. Moreover, the Receivership
16 Entities paid the income taxes on their overstated income. The Receiver filed
17 amended tax returns for 2005, 2006, 2007 and 2008, as well as the pre-receiver 2009
18 return. During the previous Sixteenth Application Period, a congressional review
19 committee approved the refunds and the U.S. Treasury paid the receivership estate
20 \$9,836,596.51 for overpaid taxes and interest. Additional refunds from state taxing
21 authorities are expected. To date, the Receiver has recovered \$11,606,480.30 in
22 federal and state income tax refunds. The Receiver has also administered Qualified
23 Settlement Fund ("QSF") tax returns for the receivership estate. The QSF is not
24 expected to incur any tax liabilities.

25 During the Twentieth Fee Application nearly half or 43% of the Receiver's
26 work involved managing and supporting the Receiver's litigation against former
27 corporate counsel, including law and motions, mediations, settlements, damage
28

1 analysis, discovery requests, document production, and the deposition of the
2 Receiver . The vast majority of the remainder of the bill for the Twentieth
3 Application Period was spent supporting investor and claimant inquiries concerning
4 claims arising from the first distribution of \$117,500,000 which was paid to nearly
5 9,000 recipients. The Receiver's staff also assisted the note holder plaintiff's
6 distribution of the settlement proceeds from the bond indenture trustees.

7 The Receiver also defended and settled the Interstate action, monitored and
8 collected revenue from the film, monitored and collected loan and accounts
9 receivable payments, and marketed other debt and equity positions of the
10 Receivership Entities, enforced judgments, as well as monthly reporting to the
11 parties and the Court.

12 The Receiver's efforts resulted in gross receipts to the receivership estate in
13 the amount of \$57,194.68 during the Twentieth Application Period and can be
14 broken down into the following categories:

24 While the vast majority of significant assets have been liquidated, there are
25 numerous problem loans in which the Receivership Entities holds an interest.
26 Many have been converted to a judgment or a bankruptcy claim, a handful require
27 continued legal action, much of which is being done for little or no cost by local
28

1 counsel. Some of these loans have a prospect of at least some recovery. The
2 Receiver continues his efforts to collect on the TEEM loan, the Pyramid/Mavusi
3 judgment, the Valley/Kroop matters, the Single Touch equity position, and the
4 Lavipharm investment.

5 The Lavipharm matter has involved extensive analysis of the value of the
6 company's licenses, patents and intellectual property, as well as the status of the
7 wind down of Lavipharm brought about by the parent company. The Receiver
8 commissioned a broker during the Seventeenth Application Period to sell the
9 underlying notes made to Lavipharm. The Receiver is in discussions to dispose of
10 the asset and much of the Receiver's work on this asset has involved discussions
11 held with a potential buyer of the asset and preparation of documentation, needed
12 disclosures and sale procedures for potential overbidders.

13 The gross receipts of the receivership estate, the Receiver's fees, and the
14 Receiver's fees as a percentage of gross receipts are summarized below.

21 The fees incurred by the Receiver for the duration of the receivership are
22 2.9% of inception to date gross revenue, and 2.6% net of the holdback, i.e., the
23 portion of previously approved fees that have not been paid.

24 The Receiver's fees in the Twentieth Application Period were 16% more than
25 in the Nineteenth Interim Fee Application due the increased needs of the litigation
26 and resolution of the estate's claims against former corporate counsel, but are 70%
27 less than the First Interim Fee Application. The Receiver expects the next fee

28

1 application to decline to approximately the \$60,000 range, with significant declines
2 following that.

3 As of October 31, 2014, the Receiver was holding cash in the amount of
4 \$5,338,157.09. As of December 31, 2014 the Receiver was holding \$18,770,500.87.

5
6 **III. ANALYSIS OF RECEIVER'S FEES AND RELATED METRICS.**

7 Exhibit A provides a detailed listing of each and every time entry comprising
8 the Receiver's fees. In order to assist the Court in its review and analysis of the
9 Receiver's fees, the Receiver has prepared three separate analyses. The first is a
10 breakdown by timekeeper setting forth the amount of time spent by the Receiver and
11 his agents at their respective hourly rate. The next summary is a breakdown of work
12 by functional area including debt collection, accounting, forensic accounting,
13 business management, asset sales, and investor relations, among others. The third
14 breakdown is by significant asset or loan.

15
16 **A. Charges by Timekeeper**

17 Exhibit B provides a breakdown by timekeeper setting forth the amount of
18 time spent by the Receiver and his agents at their respective hourly rates. The
19 Receiver personally expended 72.5 hours, or 24.2 hours per month, for the
20 Twentieth Application Period for a total cost of \$29,000.00. During the Twentieth
21 Application Period the Receiver spent 14% of his time working on the Medical
22 Capital receivership.

23 In order to manage the receivership in a cost effective manner, the Receiver
24 delegates some assignments to agents who are billed at hourly rates ranging from
25 \$60 to \$175 per hour. These agents perform accounting, financial analysis, business
26 management, forensic accounting, investor relations and claims management, debt
27 collection, litigation support, real estate management, management of asset

1 disposition and other services required by the receivership estate. During the
 2 Twentieth Application Period, the Receiver's agents expended 712.6 hours cost of
 3 \$79,902.50, or \$112 per hour. The Receiver expects the number of hours necessary
 4 to administer the receivership estate to continue to decline in the next and
 5 subsequent fee applications.

6 By using qualified agents at significantly lower hourly rates than the
 7 Receiver, the Receiver was able to achieve a weighted average hourly (blended) rate
 8 of \$139 per hour for the Twentieth Application Period and \$161 per hour from
 9 inception to date. The Receiver believes that the hourly rates charged by the
 10 Receiver are fair and reasonable given the requirements of the receivership estate.

11
 12 **B. Charges by Task**

13 Exhibit C provides a monthly breakdown by tasks performed by the Receiver
 14 and his agents, including graphs for total costs for each task by month. The total
 15 hours and cost by task for the billing period are as follows:

28 The Receiver did not charge for the cost of preparing the fee applications,
 which took 13.0 hours to prepare during the Twentieth Application Period at a cost

1 savings to the receivership estate of \$2,080.00. To date, this has saved the estate
 2 \$84,538.00.

3
 4 **C. Charges by Asset**

5 Exhibit D provides a monthly breakdown by asset of tasks performed by the
 6 Receiver and his agents. The Receiver has attempted to categorize costs by
 7 significant asset. Most assets can be tied to an MP or MPs, as applicable. The pie
 8 chart graph in Exhibit D displays the cost of work performed for each referenced
 9 asset as a percentage of the work performed for all referenced assets during the
 10 Twentieth Application Period. Not all of the Receiver's work can be tied to specific
 11 asset and there is a category for this unspecified work. This work is listed in the
 12 table below as Non-Categorized but is not included in the graph. The amount of
 13 time devoted to each asset and the related cost is as follows:

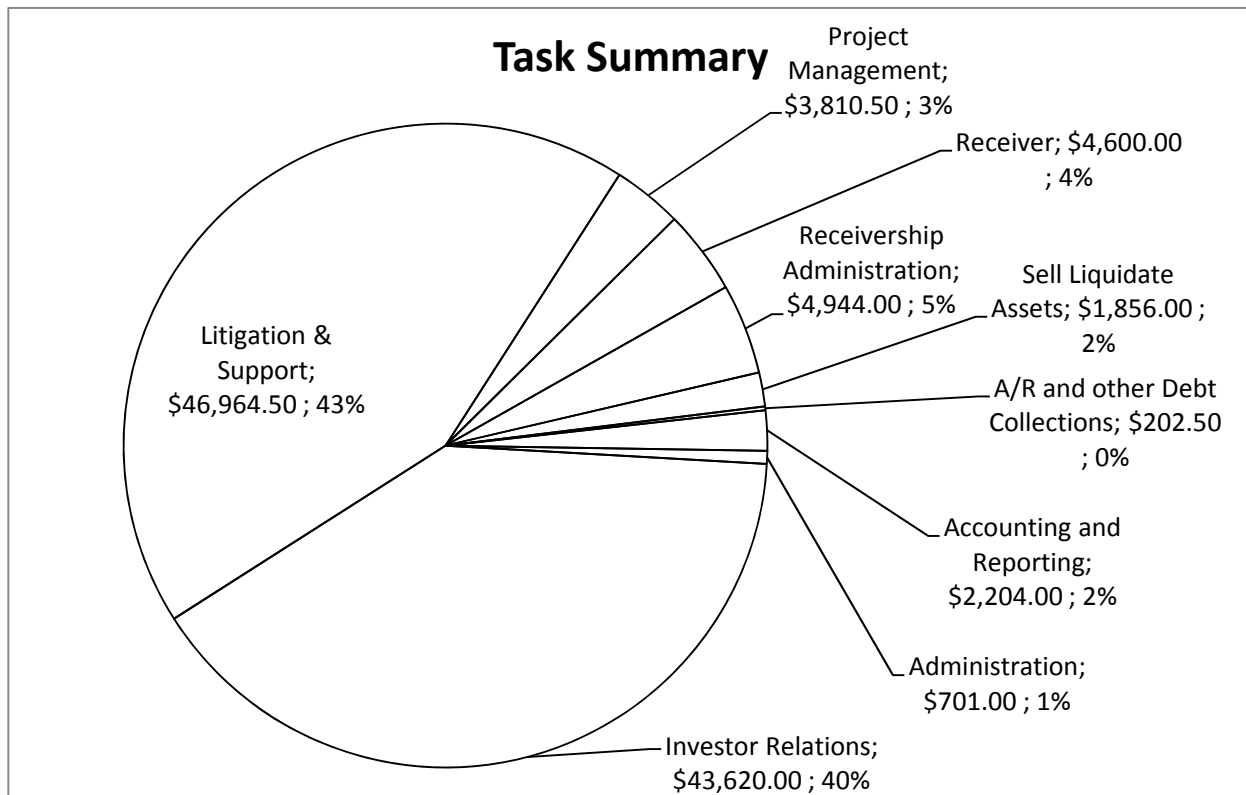

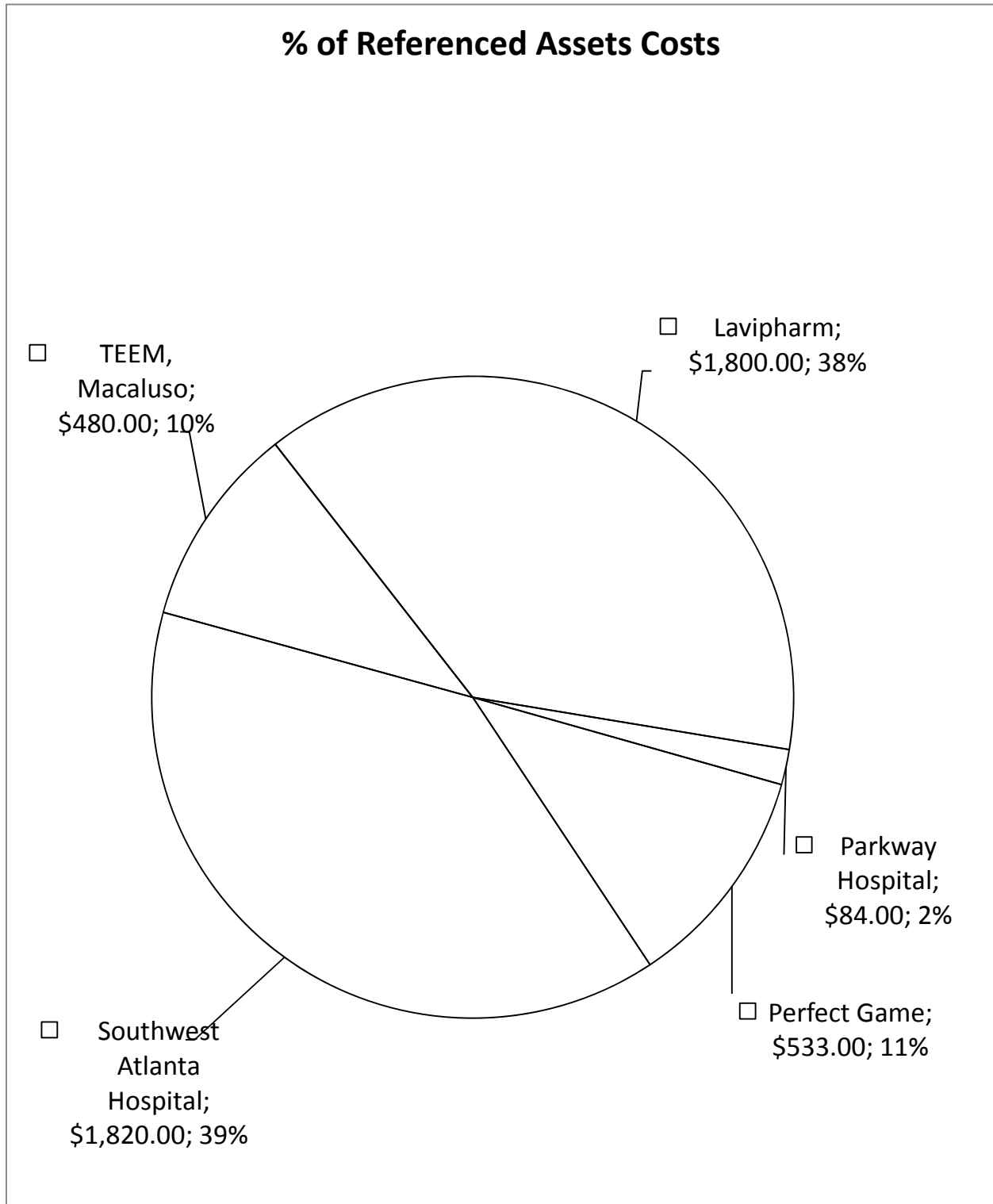
