The Twenty-Third Fee Application of Thomas A. Seaman, the court-
appointed Permanent Receiver for Medical Capital Holdings, Inc., Medical Capital
Corporation, Medical Provider Funding Corporation VI and their subsidiaries and
affiliates (collectively the "Receivership Entities") came before the Court.
Appearances were as noted on the record.

The Court having received and read the Fee Application, including any
supporting declarations and objections filed therein, and being so advised in the
matter and finding good cause, orders as follows:

1 **IT IS ORDERED** that the Twenty-Third Fee Application of Thomas A.
2 Seaman is allowed and approved for fees totaling \$283,180.00 for the Twenty-Third
3 Application Period.

4 **IT IS FURTHER ORDERED** that all of the fees incurred by Receiver
5 throughout the course of the receivership, in the total amount of \$5,459,472.00, are
6 approved.

7 **IT IS FURTHER ORDERED** that Receiver is authorized to pay 100% of
8 Receiver's fees for the Twenty-Third Application Period, or \$283,180.00, as well as
9 100% of the amounts withheld from Receiver's twenty-two interim fee applications,
10 or \$517,629.45, for a total amount of \$800,809.45, out of assets of the Receivership
11 Estate.
