The First Interim Fee Application of Forman Holt Eliades & Youngman LLC ("FHEY"), special counsel retained by Thomas A. Seaman ("Receiver"), the Court-appointed permanent receiver for Medical Capital Holdings, Inc., Medical Capital Corporation, Medical Provider Funding Corporation VI, and their subsidiaries and affiliates ("Receivership Entities") came before the Court (the "Fee Application"). Appearances were as noted on the record.

The Court having received and read the Motion papers and the Fee Application, including any supporting declarations and objections filed therein, and being so advised in the matter and finding good cause, orders as follows:

ORDERED that the First Interim Fee Application of FHEY for the Receiver of the Receivership Entities is allowed and approved in the amount of \$74,392.50 in attorneys' fees and \$2,887.36 in costs for services performed and costs incurred during the Fee Application period from January 1, 2011, through August 1, 2012; and it is further


ORDERED that the Receiver is authorized to pay 100% of the allowed amount of FHEY's fees, which amount is \$74,392.50, and to pay 100% of the allowed amount of FHEY's costs, which amount is \$2,887.36, out of assets of the Receivership Estate.
